INFORMATION CLAUSE FOR CONTRACTORS

ANDROPOL JOINT-STOCK COMPANY BASED IN ANDRYCHÓW

In accordance with the provisions of Regulation (EU) 2016/679 of the European Parliament and of the Council of 27 April 2016 on the protection of natural persons with regard to the processing of personal data and on the free movement of such data and repealing Directive 95/46/EC (hereinafter referred to as "GDPR"), we inform you as a contractor of the Company that:

I. IDENTITY AND CONTACT INFORMATION OF THE ADMINISTRATOR

II. PURPOSES AND LEGAL BASIS OF PERSONAL DATA PROCESSING

Your personal data will be processed:

- 1. on the basis of Article 6(1)(b) of the GDPR for the purposes necessary to perform the contract concluded with you or to take actions at your request before concluding such contracts;
- 2. in order to fulfill legal obligations incumbent on the administrator, on the basis of Article 6(1)(c) of the GDPR, including but not limited to. obligations arising from tax and accounting regulations, including obligations to archive (store) personal data, and from the provisions of the Civil Code, including obligations related to the processing of complaints reported under the warranty regulations;
- 3. on the basis of Article 6(1)(f) GDPR for the purpose of possible establishment, investigation or defense against claims being the realization of our legitimate interest in this regard.

IV. TRANSFER OF PERSONAL DATA TO A THIRD COUNTRY

As a rule, the Administrator does not transfer your personal data to a third country. The exception in which your personal data may be transferred to a third country is the transfer of such data performed by the provider of the Office 365 software and Sharepoint service, namely Microsoft Ireland Operations Limited, which informs that in certain situations data may be transferred to the United States of America. In doing so, the aforementioned company informs that it relies on standard contractual clauses according to European Commission guidelines and the DPF (Data Privacy Framework) agreement for the transfer of data.

V. RETENTION PERIOD OF PERSONAL DATA

Your personal data will be stored by the administrator until the statute of limitations for potential claims related to the performance of the contract, and in the scope of data in respect of which the applicable law prescribes their storage for a longer period - until the expiration of this period. Such a

longer period of time is specified, for example, for accounting evidence relating to commercial contracts, which, in accordance with the Accounting Act, are kept for 5 years from the beginning of the year following the fiscal year in which operations, transactions and proceedings were finally completed, paid off, settled or time-barred.

VI. RIGHTS OF THE DATA SUBJECT

You have the right to request from the administrator access to, rectification, erasure (pursuant to Article 17 of the GDPR) or restriction of processing (pursuant to Article 18(1) of the GDPR) of personal data concerning you. In order to exercise any of the above rights, you should address the relevant request to the administrator, e.g. in person, by phone, by email or by correspondence, using the administrator's contact information indicated in point I. above.

VII. RIGHT TO OBJECT

To the extent that the processing of your personal data is based on Article 6(1)(f) of the GDPR, you have the right to object at any time - for reasons related to your particular situation - to the processing of your personal data, pursuant to Article 21(1) of the GDPR. In order to exercise your right to object, you should address a relevant request to the administrator, e.g. in person, by phone, email or by correspondence, using the administrator's contact information indicated in point I. above.

VIII. RIGHT TO LODGE A COMPLAINT TO THE SUPERVISORY AUTHORITY

You have the right to lodge a complaint to the supervisory authority if you believe that the processing of your personal data by the administrator violates the provisions of the GDPR. Pursuant to Article 77 of the GDPR, a data subject has the right to lodge a complaint with a supervisory authority, in particular in the Member State of his or her habitual residence, his or her place of work or the place where the alleged GDPR violation was committed. The supervisory authority in the Republic of Poland is the President of the Office for Personal Data Protection.

IX. REQUIREMENT TO PROVIDE PERSONAL DATA

The provision of your personal data for the purpose of performance of the contract is a contractual requirement, i.e. refusal to provide personal data may prevent you from entering into a contract with the Company.

X. AUTOMATED DECISION-MAKING, INCLUDING PROFILING

The Administrator does not perform automated decision-making or profiling.
